### **Public Participation at Town Council Meetings**

After an item has been introduced, any person wishing to address the council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation, if the affiliation is relevant, prior to making other comments. All remarks should be addressed to the Town Council. Comments shall be limited to three minutes per person; however, the time may be extended by majority vote of councilors present. For agenda items that are not formally advertised public hearings, the time for public comments is limited to 15 minutes per agenda item. This time may be extended by a majority of the Town Council. The chairman may decline to recognize any person who has already spoken on the same agenda item and may call on speakers in a manner so as to balance debate. Once the Council has begun its deliberations on an item, no person shall be permitted to address the Council on such item.

#### Speaking at the meeting on topics not on the agenda at regular Council meetings

Persons wishing to address the Council on an issue or concern local in nature not appearing on the agenda may do so at a regular Town Council meeting before the town manager's report and/or after the disposition of all items appearing on the agenda. Any person wishing to address the Council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation if the local affiliation is pertinent. Comments in each comment period shall be limited to three minutes per person and 15 minutes total; however, the time may be extended by majority vote of councilors present.

### Decorum

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chairman.

## Item #31-2020 Town Center <u>Sidewalk</u> – Segment #1

Stephen Harding, Town Engineer will be present to provide an overview of the project.

The Town will be constructing 3 sections of sidewalks in the town center in 2020 and 2022. Town Center Sidewalk Segment 1 is proposed for construction in 2020. Segment 1 is located on the northern end of the town center, on the east side of Ocean House Road, extending from Cumberland Farms to the Methodist Church. The sidewalks are being designed to match the Town Center standard.

This project is a PACTS Municipal Partnership Initiative (MPI) Agreement between MaineDOT, the Town of Cape Elizabeth and PACTS.

## **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council accepts and appropriates the \$90,000 grant from the Portland Area Comprehensive Transportation System – Municipal Partnership Initiative Agreement for the period August 20, 2019 through 2024 for the Town Center Sidewalk – Segment 1 project with the remaining local share to be included in the Fiscal Year 2021 budget.

The fee will be revisited in March for years after 2020.

## Item #34-2020 Review of Wetland Regulations

Recommendation #48 of the Comprehensive Plan-Review and update the Resource Protection Permit standards to emphasize avoidance and minimization of wetland alterations.

Suzanne McGinn emailed the town council on January 25, 2020 asking the town council to consider stricter local wetland restrictions for development in Cape Elizabeth where vernal pools are present. Ms. McGinn's request to review stricter wetland regulations is consistent with Recommendation #48 of the 2019 Comprehensive Plan.

The town council will consider whether to refer Recommendation #48 of the 2019 Comprehensive Plan to the ordinance committee for review.

## Item #35-2020 Write-Offs of Uncollectible Real Estate Tax Liens

## Opportunity for Public Comment (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.)

The finance director is recommending the write-off of uncollectible real estate tax liens from 1981 - 2016 for an amount of \$16,713.15.

## **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council authorizes the Town Treasurer to write-off \$16,713.15 in real estate tax liens representing 22 properties for the period 1981 through 2016 as one property's liens having been satisfied and discharged but not taken off the books; one property's tax liens were based on an improper assessment for property outside of the Town and should have been taken off the books; eight tax lots being fractional ownership of a single lot that the Town took possession of and should have been released from the tax records; and 12 properties having been abandoned and which the Town took possession of and should have released the tax liens from the tax records. ## Item #36-2020 Hardscape Improvements at Portland Head Light

On October 16, 2019, Item #143-2019, the town council authorized the funding of hardscaping pedestrian improvements at Portland Head Light in an amount not to exceed \$90,000 to be provided by the Portland Head Light Fund. The improvements were sent to bid, and the bids received were greater than the estimated \$90,000. The town manager is recommending \$40,000 be transferred from the unassigned fund balance to the Portland Head Light Fund to pay for the difference in the cost of the project and professional services related to the design, project administration, construction administration, and site inspections.

### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council authorizes the transfer of \$40,000 from the unassigned fund balance to the Portland Head Light Fund to pay for the difference in cost of the previously authorized \$90,000 on October 16, 2019 and professional services related to the design, project administration, construction administration and site inspections.
