## COVID-19 Update

In response to the recent outbreak of Coronavirus Disease 2019 (COVID-19) the Governor signed LD 2167, An Act To Implement Provisions Necessary to the Health, Welfare and Safety of the Citizens of Maine in Response to the COVID-19 Public Health Emergency, which is now PL 2019, c. 617.

Part G enacts Title 1, section 403-A, Public proceedings through remote access during declaration of state of emergency due to COVID-19. It authorizes conducting public proceedings through telephonic, video, electronic or other similar means of remote participation with specific conditions. The section is repealed 30 days after the termination of the state of emergency.

#### **Public Participation at Town Council Meetings**

After an item has been introduced, any person wishing to address the council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation, if the affiliation is relevant, prior to making other comments. All remarks should be addressed to the Town Council. Comments shall be limited to three minutes per person; however, the time may be extended by majority vote of councilors present. For agenda items that are not formally advertised public hearings, the time for public comments is limited to 15 minutes per agenda item. This time may be extended by a majority of the Town Council. The chairman may decline to recognize any person who has already spoken on the same agenda item and may call on speakers in a manner so as to balance debate. Once the Council has begun its deliberations on an item, no person shall be permitted to address the Council on such item.

## Speaking at the meeting on topics not on the agenda at regular Council meetings

Persons wishing to address the Council on an issue or concern local in nature not appearing on the agenda may do so at a regular Town Council meeting before the town manager's report and/or after the disposition of all items appearing on the agenda. Any person wishing to address the Council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation if the local affiliation is pertinent. Comments in each

comment period shall be limited to three minutes per person and 15 minutes total; however, the time may be extended by majority vote of councilors present.

#### **Decorum**

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chairman.

The town council has received a request from residents for a reduction in the speed limits on streets located in the Oakhurst neighborhood from the standard 25 mph to 15 mph.

The council has received an email raising an issue regarding the regulation of child care facilities.

The town council will discuss this correspondence and determine if the regulation of this and similar businesses that are currently subject to site plan review should be referred to the Ordinance Committee for review and recommendation.

ORDERED, the Cape Elizabeth Town Council accepts and appropriates a \$1,000.00 award from the Enforcing Underage Drinking Laws grant, which is made and overseen by Dirigo Safety, LLC. The grant period is September 8, 2020 to June 20, 2021.

## Item #134-2020 Approval of the Transfer of Forfeiture Assets

Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. The State of Maine Office of the Attorney General has notified Chief Paul Fenton that a forfeitable item may be transferred to the Town of Cape Elizabeth if approved by the municipal officers.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council grants approval pursuant to 15 M.R.S. §5824(3) & §5826(6) to transfer forfeited assets in the case State of Maine v. Kenneth Jules LaFlamme, Defendant; And \$2,000 U.S. Currency, Defendant(s) In Rem.

#### Item #135-2020 Discuss the Formal Creation of a Bottle Shed Committee

**Opportunity for Public Comment** (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

Currently two members of the community and a staff person serve on the ad-hoc Bottle Shed Committee. The committee reviews options for the allocation of proceeds from bottles and cans collected at the Bottle Shed. Funds are intended to benefit Cape Elizabeth-based not-for-profit and non-profit service clubs and organizations that benefit the youth of Cape Elizabeth.

Annually applications are accepted from organizations to apply for funding. Organizations must be based in Cape Elizabeth and provide the organization's tax identification number and a W-9.

The town council will discuss creating a standing committee which will require an amendment to Chapter 4 Boards and Committees.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council refers to the appointments committee drafting a charge and composition for a standing Bottle Shed Committee reporting back to the town council for further review and action.

### Item #136-2020 Discussion of Best Practices for 2020 Halloween Activities

**Opportunity for Public Comment** (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

The town council will discuss and possible act on recommendations for best practices for 2020 Halloween activities in light of the COVID-19 pandemic concerns.

## Item #137-2020 Town Council Vacancy

**Opportunity for Public Comment** (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

Chairman Valerie Adams is stepping down from the town council as she is moving out of town; her term was to expire December 14, 2020.

The Council-Manager Charter Article II Town Council Sec. 2 Qualifications provides that in the event a vacancy occurs less than 6 months prior to the next regular municipal election, the vacancy may be filled by a special election for the unexpired portion of the term. Since Ms. Adams' term was to expire December 14, 2020, nominations for the position have already been submitted for the November 3, 2020 municipal election.

It is in order for the town council to declare a vacancy with the position already being filled at the November 3, 2020 election.

The Town Council Rules Article IV Miscellaneous Provisions Section 3. Chairman state in the absence of the chairman, the finance committee chairperson shall assume the responsibilities of the chairman.

Item #138-2020 Corporate Resolution to open a deposit account at Machias Savings Bank.

**Opportunity for Public Comment** (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

This is an action to establish a banking relationship with Machias Savings Bank. This is relating to the recent request for proposals for expiring certificate of deposits. After receiving five different responses, Machias Savings Bank was the apparent high bidder, with rates provided for six month certificate of deposit at 0.25% and twelve months at 0.35%.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council authorizes the opening of a new deposit account at Machias Savings Bank, and adopts the proposed corporate resolution.

Item #139-2020 Authorization to Enter into a Lease Option agreement with encore Renewable Energy at the landfill site at the Cape Elizabeth Recycling Facility.

**Opportunity for Public Comment** (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

On July 20,2020, the town council authorized the Town Manager to enter into negotiations with Encore Renewable Energy for the installation of a solar power installation at the Cape Elizabeth Recycling Center former landfill site as recommended by the energy committee. Over the past two months the Town Manager and the Town Attorney have negotiated the first step in this process for the council to consider, and that is the lease option agreement.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council authorizes the Town Manager to enter into the 2-year Lease Option Agreement (the "Option") now, and further authorize you to enter into a 25-year Site Lease Agreement (the "Ground Lease") in substantially the same form as attached to the Option, in the event that Encore Redevelopment LLC ("Encore") exercises its Option, all subject to final review and approval by the Town Manager and Town Attorney. The Option gives Encore the right to extend the Option for an additional year upon payment of \$1,000. The Ground Lease gives Encore the right to extend the term of the Ground Lease for two (2) five year terms.

## Item #140-2020 Executive Session- Request for Hardship/Poverty Tax Abatement

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council enters into executive session in conformance with 1 MRS §405 6 F to consider a request for an abatement of property taxes based on hardship or poverty.

Citizens may at this point in the meeting raise any topic that is not on the agenda that pertains to Cape Elizabeth local government. (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.
