10. Item #112-2021 Planning Board Recommendation to Amend Chapter 19 Zoning Ordinance Relating to the Size of High Tunnel/Greenhouse Agricultural Buildings

On May 10, 2021 the town council referred a request from the William H. Jordan Farm to the planning board to increase the size of high tunnel/greenhouse agricultural buildings, Sec. 19-9-2.

The planning board discussed the item at the June 1, 2021 workshop and voted to schedule a public hearing on June 15. By a vote of 4-2 the planning board voted to refer to the town council an amendment to 19-9-2 c. to increase the building footprint from 2,000 to 3,000 sq. ft. in size.

On July 12, the town council voted to schedule a public hearing on August 9.

Due to the subject of the request, Councilors Caitlin Jordan and Penelope Jordan have abstained from discussion and voting on this item due to a conflict of interest.

ORDERED, the Cape Elizabeth Town Council approves a recommendation from the planning board to amend Chapter 19 Zoning Ordinance relating to the size of high tunnel/greenhouse agricultural buildings to increase the size from 2,000 to 3,000 sq. ft. in size.

19. Item #120-2021 Water Body Naming Project

Opportunity for Public Comment (Limited to 15 minutes; 3 minutes per person. Time may be extended by majority vote of the councilors present.) When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

On October 16, 2019 the town council referred to the conservation committee review and recommendation #72 of the Comprehensive Plan:

Recommendation #72 Assign names to significant unnamed bodies of water and streams

The conservation committee voted 6-0 on February 9, 2021 to recommend names for water bodies.

On March 8, 2021 the town council referred the conservation committee's recommendations to a workshop held on May 5. It was agreed at the workshop that a review by the Ad-Hoc Civil Rights Committee was desired.

At the July 12, 2021 town council meeting the Ad-Hoc Civil Rights Committee provided a memo relating to their June 30 review in which they found 5 proposed names to be potentially problematic; S12 Ziggy Stream, S27 Hicks Beck, S29 Rebels Run, S53 Nigawes and P10 Saunkskwak. It was a consensus of the council to request staff provide potential names for the five bodies of water and bring the recommendations back to the council for action.

Draft Motion

ORDERED, the Cape Elizabeth Town Council approves the naming of significant unnamed bodies of water and streams as recommended. The complete list appears in a memo from the Town Planner dated July 14, 2021.

5G wireless amendments to the town council. 1) It would be in order to refer the amendments to the planning board for review. 2) In addition the committee voted 3-0 to recommend the town council seek consultant expertise for a Wireless Infrastructure Market Augmentation (Wima) study. The council may consider the next step to refer to a workshop.

26. Adjournment

Public Participation at Town Council Meetings

After an item has been introduced, any person wishing to address the council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation, if the affiliation is relevant, prior to making other comments. All remarks should be addressed to the Town Council. Comments shall be limited to three minutes per person; however, the time may be extended by majority vote of councilors present. For agenda items that are not formally advertised public hearings, the time for public comments is limited to 15 minutes per agenda item. This time may be extended by a majority of the Town Council. The chairman may decline to recognize any person who has already spoken on the same agenda item and may call on speakers in a manner so as to balance debate. Once the Council has begun its deliberations on an item, no person shall be permitted to address the Council on such item.

Speaking at the meeting on topics not on the agenda at regular Council meetings

Persons wishing to address the Council on an issue or concern local in nature not appearing on the agenda may do so at a regular Town Council meeting before the town manager's report and/or after the disposition of all items appearing on the agenda. Any person wishing to address the Council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation if the local affiliation is pertinent. Comments in each comment period shall be limited to three minutes per person and 15 minutes total; however, the time may be extended by majority vote of councilors present.

Decorum

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chairman.
