11. Item #33-2022 Use of Fort Williams Park for Beach to Beach 10K Road Race August 6, 2022

On December 16, 2021 the Fort Williams Park Committee approved (5-0) the use of Fort Williams Park for the Beach to Beacon 10K Road Race. The race is scheduled for Saturday, August 6, 2022. In addition the committee approved (5-0) a fee of \$27,500 (the same rate as 2020) with an additional \$2,400 contingent on the parade ground use for tent and dinner.

Note: If Beach to Beach needs additional time for the race e.g. rolling start with staggered fields, they will need to come back to the town council for permission to extend the race hours and road closures.

Draft Motion

ORDERED, the Cape Elizabeth Town Council approves the recommendation of the Fort Williams Park Committee to approve the use of Fort Williams Park for the Beach to Beach 10K Road Race, and associated activities, as presented. The race is scheduled for Saturday, August 6, 2022. The 2022 fee is \$27,500 plus an additional \$2,400 for use of the parade ground for the VIP dinner (if the space is used).

15. Item #37-2022 Appointment of the Fair Hearing Officer

The General Assistance Ordinance, Section 7.3 The Fair Hearing Authority, requires the municipal officers to appoint a Fair Hearing Authority (FHA). "The municipal officers will appoint a fair hearing authority (FHA) that will determine, based on all evidence presented at the fair hearing, whether the claimant(s) were eligible to receive assistance at the time they applied for GA. The FHA is charged with the responsibility of ensuring that general assistance is administered in accordance with the state law and local ordinance.

The FHA may consist of the municipal officers, one or more persons appointed by the municipal officers or if designated by ordinance create a board of appeals."

Town Manager Matthew Sturgis and Town Clerk Debra Lane are nominating James T. Walsh to serve as the Fair Hearing Officer for a three-year term. A memo has been

provided relating to the nomination.

Draft Motion

ORDERED, the Cape Elizabeth Town Council appoints James T. Walsh, 53 Wildwood Drive, to serve as the Fair Hearing Officer effective immediately. The term will expire 12/31/2024.

A public hearing on the general assistance ordinance and appendices was held on October 13, 2021. Following the public hearing the town council voted to table the item for further discussion at a workshop held on October 27.

At the workshop the council suggested/hoped for future proposed changes that MMA provide a red-lined version and note what is required by law to be included in the ordinance.

Based on past council votes, the council may want to consider not adopting Appendix C Housing Maximums which would allow a maximum benefit to be all for housing if deemed appropriate by the general assistance administrator.

Hazard Mitigation

Mitigation is the work done to prevent or lessen damage from and adverse event. This can be as simple as ditching along a roadway that floods, or as complex as rebuilding roadways or changing zoning ordinances.

Cities and towns work with their local emergency managers and public works departments to determine the best use of funds and the most needed projects. Because all Cumberland County towns and cities participate in the Hazard Mitigation Plan, they are eligible to receive pre-disaster mitigation and hazard mitigation funding from the Federal Emergency Management Agency (FEMA).

The Cumberland County Hazard Mitigation Plan was revised in 2017 as part of a FEMA five-year update cycle. Each municipality provided a list on needed projects for the County Plan. CCEMA examined historical records, the expertise of the municipalities and the State mitigation plans to revise the Plan, which was approved by FEMA in March 2017.

Each municipality reviews its projects on a yearly basis, and this is used to do a yearly update to the Cumberland County Plan.

2022 Hazard Mitigation Plan

The next iteration of the Hazard Mitigation plan (2022) has been drafted. FEMA Region 1 reviewers found that the plan meets the requirements under 44 CFR and the the County Hazard Mitigation plan for 2022 is "approvable pending adoption" by Cumberland County municipalities.

21. Item #43-2022 Update from the Town Manager Relating to the Results of an RFP for Technology Equipment in the Council Chambers

Opportunity for Public Comment (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

On December 13, 2021 the town manager provided an update on the results of an RFP for equipment in the council chambers which would enable the technology for hybrid meetings and improvements to the sound system. It was a consensus of the town council that the town manager provide a funding proposal at the January 10, 2022 council meeting for consideration. The RFP estimates the project at \$64,000.

The Remote Participation Policy adopted August 30, 2021 allows meetings via remote methods

for members (as allowed by applicable state law) of the Town Council, Planning Board and Board of Zoning Appeals and the public in the public proceedings or meetings of the body.

22. Citizens may at this point in the meeting raise any topic that is not on the agenda that pertains to Cape Elizabeth local government.

(Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

23. Adjournment

Public Participation at Town Council Meetings

After an item has been introduced, any person wishing to address the council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation, if the affiliation is relevant, prior to making other comments. All remarks should be addressed to the Town Council. Comments shall be limited to three minutes per person; however, the time may be extended by majority vote of

councilors present. For agenda items that are not formally advertised public hearings, the time for public comments is limited to 15 minutes per agenda item. This time may be extended by a majority of the Town Council. The chairman may decline to recognize any person who has already spoken on the same agenda item and may call on speakers in a manner so as to balance debate. Once the Council has begun its deliberations on an item, no person shall be permitted to address the Council on such item.

Speaking at the meeting on topics not on the agenda at regular Council meetings

Persons wishing to address the Council on an issue or concern local in nature not appearing on the agenda may do so at a regular Town Council meeting before the town manager's report and/or after the disposition of all items appearing on the agenda. Any person wishing to address the Council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation if the local affiliation is pertinent. Comments in each comment period shall be limited to three minutes per person and 15 minutes total; however, the time may be extended by majority vote of councilors present.

Decorum

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chairman.
