10. Item #44-2022 Transfer of Budget Appropriation for Sidewalk CIP Projects
Jay Reynolds, Director of Public Works is requesting a \$60,000 transfer in budgeted
appropriations from the Sidewalk Repair and Improvements Account (2000-4014) to the
CIP project account for Sidewalk Segments 7 and 8 (2000-5338).

As noted in the January 20, 2022 memo from John Quartararo, Finance Director this transfer will allow the unspent budget in 2000-5338 to be carried forward into FY 2023 when the work will be accomplished.

#### 11. Item #45-2022 Transfer of Additional Funding for Sidewalk CIP Projects

On January 10, 2022 the town council approved the closing out of CIP projects; Library Improvement Project for \$77,198.00 and the Communications Tower Project for \$18,057.00. The funds were not budgeted at that time.

John Quartararo, Finance Director is recommending (memo dated 1/21/2022) the transfer of those funds totaling \$95,525 to the Sidewalk Segments 7 and 8 projects.

#### **Draft Motion**

ORDERED, the Cape Elizabeth Town Council approves the transfer of funds in the amount of \$95,525.00 from the closed CIP projects; Library Improvements (2030-4052) \$77,198.00 and Communications Tower (2000-5421) \$18,057 into the CIP project Sidewalk Segments 7 and 8 MDOT Grant (2000-5338). Any unused portion will carry forward to the next fiscal year and will lessen the impact of the FY 2023 budget on the tax rate.

The Cape Community Arena Group provided an update to the town council at the January 10, 2022 meeting. The council further discussed the proposal at the February 7 workshop including a proposed Memorandum of Understanding (MOU) from CCAG.

Based on the February 7 workshop discussion, the town's attorney is amending the MOU for council consideration. The revised document will be reviewed in March.

The council will discuss next steps.

#### 16. Item #50-2022 Spurwink Avenue Culvert Feasibility Study Funding

Maureen O'Meara, Town Planner has outlined in a memo dated January 28, 2022 that the Wells National Estuarine Research Reserve (NWERR) is offering to include the Spurwink Avenue culvert in a funding request to be submitted to the Maine Coastal Program.

Prior collaborations between the Town and NWERR include funding assistance for the Cape Elizabeth Culvert and Habitat Assessment Study in 2019. In addition NWERR assisted in obtaining funding for the study of the Sawyer Road culvert and funds to replace the Willow Brook culvert.

ORDERED, the Cape Elizabeth Town Council endorses the inclusion of the Spurwink Avenue culvert on the list of priority projects submitted by the Wells National Estuarine Research Reserve to the Maine Coastal Program for the southern Maine region.

## 19. Item #53-2022 Proposed Funding of Technology Equipment in the Council Chambers

Opportunity for Public Comment (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

On December 13, 2021 and January 10, 2022 the town manager provided updates on the results of an RFP for equipment in the council chambers which would enable the technology for hybrid meetings and improvements to the sound system. The cost of the project is \$66,050.12.

#### **Draft Motion**

ORDERED, the Cape Elizabeth Town Council approves the recommendation of the town manager to expend \$66,050.12 from identified savings in the current year capital improvement budget for equipment in the council chambers which will enable the technology for hybrid meetings and improvements to the sound system.

## **Public Participation at Town Council Meetings**

After an item has been introduced, any person wishing to address the council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation, if the affiliation is relevant, prior to making other comments. All remarks should be addressed to the Town Council. Comments shall be limited to three minutes per person; however, the time may be extended by majority vote of councilors present. For agenda items that are not formally advertised public hearings, the time for public comments is limited to 15 minutes per agenda item. This time may be extended by a majority of the Town Council. The chairman may decline to recognize any person who has already spoken on the same agenda item and may call on speakers in a manner so as to balance debate. Once the Council has begun its deliberations on an item, no person shall be permitted to address the Council on such item.

# Speaking at the meeting on topics not on the agenda at regular Council meetings

Persons wishing to address the Council on an issue or concern local in nature not appearing on the agenda may do so at a regular Town Council meeting before the town manager's report and/or after the disposition of all items appearing on the agenda. Any person wishing to address the Council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker

shall give his or her name and address or name and local affiliation if the local affiliation is pertinent. Comments in each comment period shall be limited to three minutes per person and 15 minutes total; however, the time may be extended by majority vote of councilors present.

#### Decorum

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chairman.
