#### 11. Item #67-2022 Appointment of Election Wardens and Clerks

Pursuant to state law (Title 21-A Section 501) in a town, with the approval of municipal officers, the clerk of the municipality shall appoint a warden and may appoint one or more deputy wardens to assist in the duties on election day. If the clerk appoints another person as warden, the clerk may serve as deputy warden. Duties include maintaining order of the polling place, enforcing election laws, supervising election officials, designating a location at the voting place for persons collecting signatures and other duties as needed.

Pursuant to state law (Title 21-A Section 503-A), municipal officers of each municipality

shall appoint election clerks no later than May 1st of the even-numbered years to serve at the polling place. An election clerk holds office for 2 years from the date of appointment and until a successor is appointed and qualified. Duties include checking voters at the incoming list, overseeing the ballot box, counting ballots and other duties as needed.

Nominations for election clerks may be submitted by the municipal, county or state committees of the parties, by the municipal clerk or by any registered voter in the municipality or county.

The town clerk recommends approval of the following motion.

## 17. Item #73-2022 Recommendation of the Ordinance Committee - Selection of a Consultant for the Housing Diversity Study

On February 14, 2022 the town council authorized the reissuance of an amended Housing Diversity Study RFP as no proposals were received from the initial RFP due 1/7/2022. The deadline for the reissued RFP was March 11, 2022 and seven proposals were received. At a special meeting on March 16, 2022 the town council referred selection of a consultant to the ordinance committee with a recommendation back to the town council by April 1.

The ordinance committee met on March 23 and is recommending the selection of Camoin Associates.

The town council will consider the recommendation. Funding (\$50,000) was established previously by the council in the CIP, account 2090-4161.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council approves the recommendation of the Ordinance Committee and authorizes the Town Manager to sign a contract with Camoin Associates, Saratoga Springs, NY for a Housing Diversity Study in the amount of \$45,000 to be paid from account 2090-4161 with a completion date of 8/30/2022 as presented.

# 18. Item #74-2022 School Revolving Renovation Fund (SRRF) Bond Order - Projects at Pond Cove, Middle School and High School

Opportunity for Public Comment. Limited to 15 minutes; 3 minutes per person. Time may be extended by majority vote of the councilors present. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

The School Board voted on February 8, 2022 (6-0) to request that the Town Council approve the financing and authorize a bond order for 10 separate projects at the three schools through the SRRF Program in the amount of \$1,161.082. The State of Maine will

forgive 30% or \$348,325. The balance of funds in the amount of \$812,757 is repayable over 10 years at a zero interest rate. The first installment of \$81,276 will be payable in FY 2024.

The town council reviewed the request at a workshop on April 4, 2022.

The town council will consider the request and authorizing a bond order. Due to the length of the order it was referenced by title on the agenda, however if approved the bond order, in its entirety, will be included in the meeting minutes.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council approves the request of the School Board to approve the financing of 10 separate projects at the three schools through the SRRF Program and authorize a bond order for \$1,161.082. The State of Maine will forgive 30% or \$348,325. The balance of funds in the amount of \$812,757 is repayable over 10 years at a zero interest rate. The first installment of \$81,276 will be payable in FY 2024. Said bond order as entitled and attached:

## 19. Item #75-2022 School Construction Bond Order - Schematic Design for New Construction of Pond Cove/Middle School

Opportunity for Public Comment. Limited to 15 minutes; 3 minutes per person. Time may be extended by majority vote of the councilors present. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

The School Board voted on March 8, 2022 (6-0) to request that the Town Council authorize the bonding of up to \$650,000 with an approved bond order to enable the Town to issue short-term financing of the school building project pending a referendum vote on November 8, 2022. The intent is to finance the full cost of the schematic design for the new construction of Pond Cove/Middle School. The amount would be in addition to the \$300,000 bond order approved April 12, 2021 for the building concept design.

The town council reviewed the request at the workshop on April 4, 2022.

The town council will consider the request and authorizing a bond order. Due to the length of the order it was referenced by title on the agenda, however if approved the bond order, in its entirety, will be included in the meeting minutes.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council approves the request of the School Board to authorize the bonding of up to \$650,000 with an approved bond order to enable the Town to issue short-term financing of the school building project pending a referendum vote on the project on November 8, 2022 to finance the full cost of the schematic design for the new construction of Pond Cove/Middle School. Said bond order as entitled and attached:

### 21. Item #77-2022 Consideration of a Consent Agreement - 207 Ocean House Road

Opportunity for Public Comment. Limited to 15 minutes; 3 minutes per person. Time may be extended by majority vote of the councilors present. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

The Town Attorney has negotiated a Consent Agreement on behalf of the Town with the owner of 207 Ocean House Road, G&G Partners, LLC and recommends the Town enters into the agreement. The landowner, its successors and any future owners as well as any lessees, shall be allowed to continue using the property as a veterinary clinic without it being an accessory use to a single-family residence. Currently the Veterinary and Rehabilitation Center of Cape Elizabeth is located at 207 Ocean House Road.

#### **Draft Motion:**

ORDERED, the Cape Elizabeth Town Council authorizes the Town Manager to sign the Consent Agreement with G&G Partners, LLC relating to property at 207 Ocean House Road allowing the landowner, its successors and any future owners as well as any lessees, to continue using the property as a veterinary clinic without it being an accessory use to a single-family residence.

### 22. Item #78-2022 Consideration of a Request from Otelco Communications for an Easement

Opportunity for Public Comment. Limited to 15 minutes; 3 minutes per person. Time may be extended by majority vote of the councilors present. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

CRC Communications, LLC DBA Otelco is requesting the Town grant a 20' x 20' easement on the Town Hall parcel for the location of broadband/telecommunications equipment and permission to apply to the Planning Board for a site plan amendment.

If approved by the Planning Board, the Town would subsequently consider granting the

easement and accepting \$15,000 in exchange for the easement.

In the event the equipment is removed and the easement is no longer needed, the easement would extinguish.

ORDERED, the Cape Elizabeth Town Council grants permission to CRC Communications, LLC DBA Otelco to apply to the Planning Board for a site plan amendment to the Town Hall parcel for the location of broadband/telecommunications equipment. It is further ordered the Town Council will subsequently consider granting a 20' x 20' easement for the equipment and accept \$15,000 in exchange at a future council meeting.

### **Public Participation at Town Council Meetings**

After an item has been introduced, any person wishing to address the council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation, if the affiliation is relevant, prior to making other comments. All remarks should be addressed to the Town Council. Comments shall be limited to three minutes per person; however, the time may be extended by majority vote of councilors present. For agenda items that are not formally advertised public hearings, the time for public comments is limited to 15 minutes per agenda item. This time may be extended by a majority of the Town Council. The chairman may decline to recognize any person who has already spoken on the same agenda item and may call on speakers in a manner so as to balance debate. Once the Council has begun its deliberations on an item, no person shall be permitted to address the Council on such item.

# Speaking at the meeting on topics not on the agenda at regular Council meetings

Persons wishing to address the Council on an issue or concern local in nature not appearing on the agenda may do so at a regular Town Council meeting before the town

manager's report and/or after the disposition of all items appearing on the agenda. Any person wishing to address the Council shall signify a desire to speak by raising their hand or by approaching the lectern. When recognized by the chairman, the speaker shall give his or her name and address or name and local affiliation if the local affiliation is pertinent. Comments in each comment period shall be limited to three minutes per person and 15 minutes total; however, the time may be extended by majority vote of councilors present.

#### **Decorum**

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chairman.
