# 2. Stormwater Amendments

Opportunity for Public Comment. Limited to 15 minutes; 3 minutes per person. Time may be extended by majority vote of the councilors present. When recognized by the chair, the speaker shall give their name and address or local affiliation, if the affiliation is pertinent.

On August 8, 2022 the Town Council referred to the Ordinance Committee development of stormwater ordinance amendments (Chapter 25 Storm Water) required by the General Permit for Stormwater Discharges (2022 MS4 General Permit).

On December 12, 2022 the Town Council received the Ordinance Committee report and referred proposed amendments to workshop and Chapter 16 Subdivision Ordinance and Chapter 19 Zoning Ordinance amendments to the Planning Board for review and report back to the council.

The council may want to hold the Chapter 25 Storm Water amendments until a recommendation from the Planning Board is received. Upon receipt the complete stormwater package can be set to public hearing.

# **Participation at Meetings and Conduct of Meetings**

Workshop Meetings

The purpose of a workshop meeting is primarily for council dialogue involving reports and proposals from council members, committees and staff that may be considered at later Town Council meetings. The Town Council may give guidance to the chair and to staff at workshop meetings but no decisions may be made that require formal votes. Notwithstanding the prior sentence, the Town Council may vote on procedural motions at a workshop meeting to determine a conflict of interest, to enter into executive session and to adjourn. Prior to Town Council discussion on any item, members of the public may speak on each agenda item for not more than three minutes each and up to a total of 15 minutes. If there are more speakers than the time available, the chair may allocate the speaking time in order to balance the debate. The public participation portion shall conclude when the Town Council begins its discussions.

Decorum

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chair.
